Privacy Policy

When you provide us with information through jerryhart.com, we respect your privacy. It is important for you to understand what information we collect about you during your visit and what we do with that information. We have a strict policy where we do not rent or sell your information to anyone, for any reason. Your visit to jerryhart.com is subject to this privacy policy and our terms and conditions. Please note that this privacy policy governs only information provided to jerryhart.com and communications from jerryhart.com. It does not govern any other information or communications that may reference Hart Creative Marketing, e.g., communications from other e-retailers or brick and mortar stores. This privacy policy was last updated 10/1/2004.



Collection of Personal Information

We do not collect personally identifiable information about you, except when you provide it to us. For example, if you decide to complete a user registration form or online survey, you may be asked to provide certain information such as your contact information (name, e-mail address, mailing address, and telephone number), age group, gender, and product concerns, and the brands and products you use. If you decide to place an order, we will also need to know your delivery and billing address, credit card number, expiration date and other identifying information, as applicable. To protect your personal information, users registering at jerryhart.com must also enter a user name/e-mail address and password. If you would prefer that we not collect any personally identifiable information from you, please do not provide us with any such information.

When you submit your personally identifiable information on jerryhart.com, you are giving your consent to the collection, use, and disclosure of your personal information as set forth in this privacy policy.



Opt-In Communications and Third Party Involvement

If you opt-in during the registration process or at other times when you submit personally identifiable information, the information you provide may be used by our third-party marketing company who assist us in hosting and storing your data and who may from time to time assist in the maintenance and analysis of that data.

Except as otherwise stated herein, we will never provide your personally identifiable information to third parties for their use in marketing their products or services to you without your consent. If you do opt-in and later decide that you would no longer like to receive these communications, see the section "choice/opt out" below.

We may retain other companies and individuals to perform functions consistent with our privacy policy on our behalf. Examples include customer support specialists, web hosting companies, fulfillment companies (e.g., companies that fill product orders or coordinate mailings), data analysis firms, and e-mail service providers.

Such third parties may be provided with access to personally identifiable information needed to perform their functions, but may not use such information for any other purpose. We carefully select our partners by ensuring that they adhere to strict privacy guidelines and will never sell or rent your information. If you prefer not to receive such opt-in communications, please do not opt-in to receive these communications.

If you elect to participate in any promotions, sweepstakes, surveys, questionnaires, or other events during your visit to jerryhart.com, the rules or terms and conditions for those events may indicate that your personally identifiable information will be shared with third parties. Providing such information will happen only with your explicit permission, which may be deemed given by your participation in such events.

As our business evolves, we may sell, transfer or otherwise share some or all of our assets, including personally identifiable information, in connection with a merger, reorganization or sale of our assets or in the event of bankruptcy. In such an event, personal and anonymous information may be one of the assets transferred.



Choice / Opt-Out

You may also click the "unsubscribe" link at the bottom of any e-mail opt-in communication you receive from us and follow the instructions provided therein.



Use of Collected Information

If you have elected to provide us with your personal information, e.g., by registering on jerryhart.com, e-mailing our customer service department, or placing an order, we may provide you with service related announcements concerning jerryhart.com or contact you regarding your customer service requests or your order. For example, all registered users will receive a welcome e-mail to confirm their registration. These types of communications are necessary to serve you, respond to your requests or concerns, and to provide the high level of customer service that jerryhart.com offers its customers. We may also use your personal information to facilitate your interactions with other companies from which you have purchased products or services, provide you with information you requested regarding products or services and to provide you with ongoing support. Only upon your explicit direction or consent, we will forward your personal information to third parties that you desire to contact you or to provide to you products or services described on the site.

We may use the information you provide in aggregate (non-personally identifiable) form for internal business purposes, such as generating statistics and developing marketing plans. We may collect, store, or accumulate certain non-personally identifiable information concerning your use of jerryhart.com, such as information regarding which of our pages are most popular. We may share or transfer non-personally identifiable information with or to our affiliates, licensees, and business partners.



Compliance with Laws

We may disclose any information, including personally identifiable information, we deem necessary, in our sole discretion, to comply with any applicable law, regulation, legal process, or governmental request or to protect our property or interests or those of our agents and employees or the public and to protect public safety. We may also exchange information, including personally identifiable information, with other companies and organizations for credit fraud protection and risk reduction. Under such circumstances, we may be prohibited by law, court order or other legal process or considerations from providing notice of the disclosure, and we reserve the right to not provide such notice in our sole discretion.



Use of Cookies and Log Files

We may place a "cookie" on your computer's hard drive so we can recognize you as a return user and personalize your experience. A cookie is a piece of data that enables us to track and target your preferences. The cookie will be stored on your computer's hard drive until you remove it. We may also use temporary or "session" cookies to help you navigate our site. These cookies will expire when you leave the site. You can have your browser notify you of, or automatically reject, cookies. If you reject our cookies, you may still use jerryhart.com, but you may be limited in the use of some of the features.
